Responsible use agreement

Introduction

Silverdale School believes in a Digital Citizenship model for supporting safe and responsible use of the internet in teaching and learning. An important part of this is that we are able to show others what that responsible use looks like while we are using technology in our learning.

We think a good digital citizen is someone who;

- is a confident and capable user of ICT
- will use ICT for learning as well as other activities
- will think carefully about whether the information they see online is true
- will be able to speak the language of digital technologies
- understands that they may experience problems when using technology but can deal with them
- will always use ICT to communicate with others in positive ways
- will be honest and fair in all of their actions using ICT
- will always respect people's privacy and freedom of speech online
- will help others to become a better digital citizen

Because we know this is important for us all, we ask everyone, the staff, students and volunteers working at the school to agree to use the internet and other technologies in a safe and responsible way by following the rules laid out in a Responsible Use Agreement like this one.

If someone cannot agree to act responsibly, or the things that they do mean that other people are being harmed or disrespected, then we might stop them from using the internet and other technology at school.





Terms of Use Agreement

Student Agreement

Devices: All Students

- I will use devices for educational purposes only and websites used will be of educational benefit.
- I will respect the equipment and endeavour to keep it safe, including not leaving it on the floor, walking around with a laptop open and not having food and/or drink near the device.
- I will not use screensavers, backgrounds or pictures that are offensive.
- If at any time I have permission to bring my own device (including mobile phone) to school, I will give it to my teacher/office for safe keeping during school hours and I understand that the school takes no responsibility for loss or damage of the device.

1:1 Chromebook Use: Y5 – Y8

- I will know where my chromebook is at all times and will be the only individual using the device.
- I will NOT loan the chromebook or cords to other individuals.
- I will be responsible for ensuring the chromebook is put on charge in the storage unit at the end of each school day.
- I will return the chromebook and all its peripherals in good working condition.

Google accounts: Y3 – Y8

- I understand that my Google account is school property. Teachers can access my account at any time and are able to monitor my use.
- I will produce work and use this space in a way that I would be proud to show my teacher.
- I will keep my password private from other students and will not change my password without the school administrator's permission.
- I will not use school Google accounts to set up other accounts on the internet without teacher permission,
- I will show "digital citizenship" in these spaces and leave a positive digital footprint, respecting myself and others at all times.

***These terms of use also apply to any BYOD devices that you have been permitted to bring in at any given time.**

***Failure to follow the agreed etiquette will result in the suspension of the school chrome account and removal of the device for use.**

Student Declaration

I understand that these guidelines for responsible use are to be followed when using any technology whilst at school or whilst on any school activity. I am aware that this may include the use of a device that the school does not own.

I understand that if I breach this responsible use agreement, I may lose access to school ICT services including the use of the internet, on school owned devices or any personally owned device used at school.

I understand that our school has a policy and associated procedures* which outlines the schools digital citizenship approach and how this supports teaching and learning.

I understand that the school provides access to the internet and other communications technologies because it believes that they enhance the teaching and learning process.

I understand that the school encourages responsible behaviour by students when using technology to help protect themselves and each other from experiencing harm online. I am aware that this "Responsible Use Agreement" is part of that, and that it encourages students to consider how their actions can affect themselves and those around them.

I have read the student declaration and have talked with my child about what it means to them. I am happy that my child understands what this means, and that they are capable of working within the guidelines.



I am aware that students can experience challenges when using technology, but that the school makes every effort to support students to manage those challenges effectively. I understand that by learning to deal with them in a safe environment with the appropriate support they will be better prepared to deal with those challenges in the future.

Students image – I give permission to use my child's image (printed, digital or video) to be used where appropriate. E.g. newsletter, blog, website, classroom displays etc.

Email – I give permission for my email

_____ to be used for newsletters, notifications, fundraising initiatives and emergencies such as evacuations and lockdowns etc.

If I have questions or concerns about the way in which technology is being used by my child at school, I know the school is happy to discuss this with me, and I am aware that I am welcome to do this at any time.

Parent / Guardian Agreement

- I acknowledge that I will be responsible for the cost of repairing the chromebook if it is damaged, by my child, up to a value of \$100.
- I acknowledge that my child and I are to follow the expectations in the Terms of Use Agreement and that failure or violation of these guidelines may result in your child losing access to the device and account, or in the case of serious misconduct incidents, facing disciplinary action.
- I will be responsible for monitoring my child's use of the internet when he/she is not at school.
